**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of February 22, 2010 by **ARES CAPITAL CORPORATION** ("Lender"), a Maryland corporation with a place of business at 280 Park Avenue, 22nd Floor East, New York, NY 10017, in connection with the grant of security interests in certain trademarks by **3095084 NOVA SCOTIA LIMITED**, a Canadian corporation, **3091779 NOVA SCOTIA INC.**, a Canadian corporation and **LAURA SECORD GP**, a Canadian partnership, each with an address of 2700 Matheson Blvd. East, Suite 800, East Tower, Mississauga, Ontario, Canada L4W 4V9 (each an "Assignor" and collectively the "Assignors"), in favor of Ares Capital Corporation.

WITNESSETH:

WHEREAS, the Assignors entered into an agreement with the Lender which was recorded in the Trademark Division of the United States Patent and Trademark Office on November, 6, 2007 at Reel 003656, Frame 0084 for the purpose of providing certain trademarks as collateral security for the payment and performance of certain obligations of the Assignors to the Lender; and

WHEREAS, the Lender now desires to terminate and release the entirety of its security interest in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Definitions. The term "***Trademark Collateral***", as used herein, shall mean all of the Assignors' right, title and interest of every kind and nature as of the date hereof in the Assignors' trademarks (including, without limitation, those items listed on Schedule A thereto).
2. Release of Security Interest. The Lender hereby terminates, releases and discharges its security interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.
