

1. I am personally familiar with the facts stated herein;

2. On March 15, 2002, a merger document was recorded at Reel 2461/0741 between Imasco Enterprises, Inc. and Imasco Limited with respect to U.S. Trademark Reg. No. 2,286,859;
3. Imasco Enterprises, Inc. and Imasco Limited were related companies to my employer Imperial Tobacco Canada Limited, and Imasco Limited still is;
4. The merger document was recorded against Reg. No. 2,286,859 in the assignment records of the U.S. Patent and Trademark Office in error. Imasco Enterprises, Inc. never owned any interest in Registration No. 2,286,859.
