ASSIGNMENT OF TRADEMARK RIGHTS

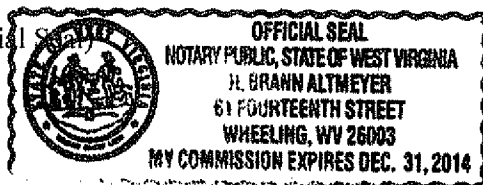
