REQUEST TO DISCHARGE NOTICES OF SECURITY INTERESTS OVER TRADEMARKS (USPTO)

WHEREAS Club de Hockey Canadien, Inc. ("CHC") and L'Aréna des Canadiens Inc. ("L'Aréna", collectively with CHC being the "Team Entities") are the owners of the United States trademarks and trademark applications listed in Schedule "A" attached hereto (collectively, the "Trademarks");

WHEREAS the Team Entities granted in favour of CIT Financial Ltd. for the benefit of CIT Lending Services Corporation (collectively, "CIT") hypothecs and security interests (the "Security Agreements"), as security for certain obligations of the Team Entities to CIT, including, without limitation, those under the credit agreement dated as of June 27, 2006 by and between, *inter alia*, the Team Entities and CIT, as amended by an amending agreement dated as of August 6, 2007, as further amended by the second amending agreement dated January 31, 2008, as further amended by the third amending agreement dated August 11, 2008, as further amended by the fourth amending agreement dated as of October 22, 2008 (collectively, as the same may be further amended, restated, supplemented or otherwise modified from time to time the "Credit Agreement") together with all related agreements, documents and instruments in connection with the Credit Agreement (the "Obligations");

WHEREAS under the Security Agreements, the Team Entities granted to CIT security interests on, *inter alia*, the Trademarks, including the goodwill and all proceeds thereof;

WHEREAS, *inter alia*, CIT Financial Ltd. and the Team Entities entered into a termination agreement dated December 1, 2009 (the "Termination Agreement");

WHEREAS CIT Financial Ltd. acknowledges and agrees that it has terminated and cancelled the Security Agreements and wishes to advise the United States Patent and Trademark Office of same in respect of the Trademarks;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. CIT hereby directs the United States Patent and Trademark Office to immediately remove and discharge all security interests registered against the Trademarks.
2. CIT hereby further directs Lavery, de Billy LLP, to perform all acts required in order to obtain the removal and discharge of all security interests registered against the Trademarks from the United States Patent and Trademark Office, and appoints Lavery, de Billy LLP, as its mandatary to obtain all information related to such discharges and removals.
