TRADEMARK ASSIGNMENT

WHEREAS, Rule Industries, Inc., a Massachusetts Corporation having offices at 1 Kendelin Road, Cape Ann Industrial Park, Gloucester, MA 01930 ("RULE"), owns all right, title, and interest in the trademarks (registered and unregistered) identified in Schedule A (hereinafter "the Marks") together with the goodwill of the business symbolized by the Marks; and

WHEREAS, Tannin Corporation, a company incorporated under the laws of Massachusetts having an office at 63 Walnut Street, Peabody, MA 01960 ("BUYER") desires to acquire and own RULE's entire right, title, and interest in and to, in all countries throughout the world, the Marks identified in Schedule A together with the goodwill of the business symbolized by the Marks.

NOW THEREFORE, be it known that, for good and valuable consideration, receipt of which is hereby acknowledged, RULE hereby sells, assigns, transfers, and sets over to BUYER, its lawful successors and assigns, RULE's entire right, title, and interest in and to the Marks identified in Schedule A and the goodwill of the business symbolized by the Marks; and RULE hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue registrations for such Marks on any applications identified in Schedule A, to issue all registrations for such Marks to BUYER, its successors and assigns, in accordance with the terms of this Assignment;

RULE HERBY further transfers and assigns to BUYER all causes of action, rights, and remedies arising under any of the Marks occurring prior to or after the effective date of this Agreement, including but not limited the right to sue for past, present and future infringement;

RULE HEREBY further covenants that RULE has the full right to convey the interest assigned by this Assignment, RULE will take all action and execute all documents necessary to perfect the interest assigned hereby;

AND, RULE HEREBY further covenants and agrees that RULE, through its officers and employees, will, without further consideration, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the Marks in said BUYER, its successors and assigns, make all rightful oaths and declarations, and generally do everything reasonably possible to aid BUYER, its successors and assigns, to obtain and enforce proper trademark protection under the Marks in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by BUYER, its successors and assigns.
