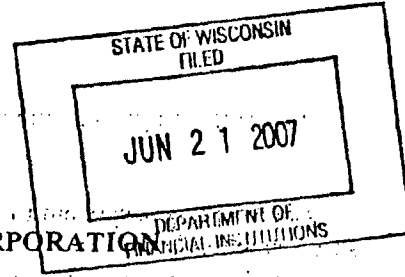

ARTICLES OF AMENDMENT
TO THE RESTATED ARTICLES OF INCORPORATION
OF

LACTOPROT USA, INC.

The undersigned hereby adopts the following Articles of Amendment to the Restated Articles of Incorporation of **Lactoprot USA, Inc.**, a Wisconsin corporation (the "Corporation"), under the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes.

1. The name of the of the Corporation is **Lactoprot USA, Inc.**
2. Article 1 of the Corporation's Restated Articles of Incorporation is hereby amended and restated in its entirety to read as follows:

ARTICLE 1: The name of the Corporation is **Dairyfood USA, Inc.**
