**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of the District of Columbia Non-profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: National Prostate Cancer Coalition Fund

SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-profit Corporation Act:

1. **Article I** of the Articles of Incorporation shall be deleted in its entirety, and the following shall be substituted therefore:

Article I.

The name of the corporation is **Zero – The Project to End Prostate Cancer** (the “Corporation”).


THIRD: The amendment was adopted in the following manner: The amendment was adopted at a meeting of the Board of Directors held on May 8, 2008, and received the vote of a majority of the Directors in office, there being no members having voting rights in respect thereof.


