TRADEMARK RELEASE, effective as of this 12 day of February, 2010, given by PNC BANK, NATIONAL ASSOCIATION (the "Agent") to PVC CONTAINER CORPORATION, A Delaware corporation, NOVATEC PLASTICS CORPORATION, a Delaware corporation, NOVAPAK CORPORATION, a Delaware corporation, AIROPAK CORPORATION, a Delaware corporation, MARPAC INDUSTRIES, INC., a New York corporation, MARPAC SOUTHWEST, INC., an Oklahoma corporation and PVC CONTAINER INTERNATIONAL SALES CORPORATION, a corporation organized under the laws of the U.S. Virgin Islands (together, collectively, the "Grantors"), as follows:

WITNESSETH


WHEREAS, the Grantors have heretofore granted to the Agent a security interest in certain U.S. trademarks and trademark licenses more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in the Revolving Credit, Term Loan and Security Agreement, dated as of August 31, 2000, between the Agent, the Grantors, and the other parties party thereto (the "Credit and Security Agreement")); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Marks to the Grantors and to dissolve any and all liens and encumbrances respecting the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quitclaims and relinquishes unto the Grantors all security interests in the Marks set forth on Schedule A granted to Agent by the Grantors pursuant to the Credit and Security Agreement, which security interest was duly recorded on September 15, 2000, at Reel 002168, Frame 0648 in the United States Patent and Trademark Office.
