ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS ("Assignment"), effective as of November 22, 2002 (the "Effective Date"), by and between TAB PRODUCTS CO., a Delaware corporation in dissolution and TAB PRODUCTS CO. LLC, a Delaware limited liability company and successor to TAB PRODUCTS CO. (collectively, "Assignor"), and DOCUCON IMAGING SERVICES, INC., a Texas corporation ("Assignee").

WITNESSETH:

WHEREAS, TAB PRODUCTS CO. was the owner of the trademark identified on Exhibit A attached hereto and the goodwill associated therewith (the "Trademark"); and,

WHEREAS, TAB PRODUCTS CO. and Assignee entered into an Asset Purchase Agreement dated as of November 22, 2002 (the "Asset Purchase Agreement") which provided for, among other things, the sale to Assignee of certain assets of TAB PRODUCTS CO. used or useable in the conduct of TAB PRODUCTS CO.'s business of providing electronic imaging services to convert documents to electronic formats for computer system access including, but not limited to, the Trademark; and,

WHEREAS, after the execution of the Asset Purchase Agreement, TAB PRODUCTS CO. filed a Certificate of Dissolution with the Secretary of State of Delaware, and TAB PRODUCTS CO. LLC became the successor to the business of TAB PRODUCTS CO., and .

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby confirm the assignment to and assign to Assignee, as of the Effective Date, all rights, title and interest in and to said Trademark, Trademark registrations, Trademark applications and the goodwill of the business symbolized thereby and the right to recover for damages and profits for past, present or future infringements thereof, regardless of whether such infringement occurred before or after the Effective Date.

Assignor agrees that it shall execute all further documents reasonably necessary to perfect Assignee's rights, title and interest in the Trademark.

This Assignment is in accordance with and subject to all of the representations, warranties, covenants, exclusions and indemnities set forth in the Asset Purchase Agreement, all of which are incorporated herein by reference. To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall control.
