RELEASE OF SECURITY INTEREST AND COLLATERAL ASSIGNMENT

THIS RELEASE dated December 23, 2009 by VantagePoint CDP Partners, L.P., as Collateral Agent, is hereinafter described:

WITNESSETH:

WHEREAS, VantagePoint CDP Partners, L.P., with its mailing address at 1001 Bayhill Drive, Suite 300, San Bruno, California 94066 ("VantagePoint"), Safe Life Corp., a Delaware corporation ("Safe Life") and Triosyn Corp., a Delaware corporation ("Triosyn" and with Safe Life, "Debtors") are parties to that certain Security Agreement dated February 27, 2009 pursuant to which Debtors granted a security interest ("Debtor Security Interest") to Collateral Agent, on behalf of itself and the purchasers ("Purchasers") of convertible promissory notes ("Notes") issued under the offering by Safe Life. The Security Interest granted Purchasers a security interest in all of the Debtor's assets, including intellectual property ("Debtor Collateral").

WHEREAS, Triosyn Holding Inc./Gestion Triosyn Inc., ("Triosyn Holding"), a corporation organized under the laws of Canada and a direct wholly owned subsidiary of Triosyn, Triosyn Research Inc./Triosyn Recherche Inc., a corporation organized under the laws of Canada and a direct wholly owned subsidiary of Triosyn Holding, and Hemo-Biotech Inc., a corporation organized under the laws of Canada and a direct wholly owned subsidiary of Triosyn, each of which is an indirect wholly owned subsidiary of Safe Life (each, a "Guarantor" and collectively, the "Guarantors" and together with Debtors, the "Conveying Parties"), are parties to that certain Guaranty Agreement dated February 27, 2009 pursuant to which Guarantors guaranteed all obligations of the Debtors under the Notes and granted a security interest ("Guarantor Security Interest" and with the Debtor Security Interest, the "Security Interests") to Collateral Agent, on behalf of itself and the Purchasers in all of the assets of Guarantors, including intellectual property ("Guarantor Collateral" and with Debtor Collateral, the "Collateral").

WHEREAS, in order to perfect the Security Interests, UCC-1 financing statements were filed against Conveying Parties in Delaware and California and a notice of the Security Interests was filed in the United States Patent and Trademark Office ("USPTO") at Reel/Frame 022521/0423 on April 8, 2009.

WHEREAS, Safe Life is consummating a qualified equity financing that will trigger the mandatory and automatic conversion of all principal and accrued and unpaid interest under the Notes into the kind of equity security issued and sold in the qualified equity financing; and

WHEREAS, in connection with the consummation of the qualified equity financing and the conversion of the Notes, all obligations under the Notes will cease and UCC-3 financing statement amendments will be filed in Delaware and California terminating the Security Interests and notice of the termination and release of the Security Interests will be filed with the USPTO. As an abundance of caution, and although not required, Conveying Parties have requested that VantagePoint, as Collateral Agent, release the Security Interests in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

VantagePoint hereby releases, for and on behalf of itself and as Collateral Agent on behalf of the Purchasers, the Security Interests in and all of its right, title and interest, if any, in and to the Collateral.
