**CONFIRMATORY TRADEMARK ASSIGNMENT**

This CONFIRMATORY TRADEMARK ASSIGNMENT, dated as of February 19, 2010, is made by Lean Healthcare Ventures, LLC, formerly known as Healthcare Performance Partners, LLC, a Tennessee limited liability company ("Assignor"), in favor of Healthcare Performance Partners, Inc., a Delaware corporation, as successor by merger to HPP Acquisition, Inc. ("Assignee").

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of November 2, 2009, among Assignor, Assignee, Charles V. Hagood and Michael F. Brown (the "Asset Purchase Agreement"), Assignor assigned to Assignee all right, title and interest in and to the LEAN HEALTHCARE EXCHANGE trademark (the "Trademark");

WHEREAS, as of the date hereof, Assignor is the record owner of U.S. trademark application number 77/834015 filed September 24, 2009 for the Trademark in International Class 041 (the "Trademark Application"); and

WHEREAS, Assignor and Assignee wish to confirm that the Trademark, the Trademark Application and all associated goodwill have been assigned to and are owned by Assignee pursuant to the Asset Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignor hereby confirms that, pursuant to the Asset Purchase Agreement, it sold, assigned, transferred and otherwise conveyed to Assignee all of Assignor's right, title and interest in and to the following:


- (a) the Trademark;
