## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is made and entered into by and between Bank of America Corporation ("Bank of America") and Merrill Lynch & Co., Inc. ("Merrill Lynch"), with an effective date of January 31, 2010 (the "Effective Date").

WHEREAS, on September 15, 2008, Merrill Lynch entered into an Agreement and Plan of Merger (as amended by Amendment No. 1 dated as of October 21, 2008, the "Merger Agreement") with Bank of America; and

WHEREAS, pursuant to the Merger Agreement, on January 1, 2009, a wholly-owned subsidiary of Bank of America merged with and into Merrill Lynch, with Merrill Lynch continuing as the surviving corporation and a subsidiary of Bank of America (the "Merger"); and

WHEREAS, as a result of the Merger, Bank of America is presently the successor of the ongoing and existing business or portions thereof to which those certain trademarks identified in Schedule A to this Agreement having pending intent-to-use applications before the United States Patent and Trademark Office pertain; and

WHEREAS, Merrill Lynch and Bank of America desire to memorialize the conveyance, transfer, and assignment to Bank of America of all of Merrill Lynch's right, title, and interest in and to the trademarks identified in Schedule A to this Agreement (collectively, the "Merrill Lynch Marks"), together with the goodwill of the business symbolized thereby in connection with the services on which the Merrill Lynch Marks are used; and

NOW, THEREFORE, in consideration of the mutual promises set forth below and for other good and valuable consideration, the receipt of which is hereby acknowledged, Merrill Lynch and Bank of America hereby agree as follows:

1. **Assignment.** As of the Effective Date of this Agreement, Merrill Lynch hereby sells, assigns, transfers and conveys to Bank of America the entire right, title, interest in and to the Merrill Lynch Marks in the United States, together with the goodwill of the business connected with and symbolized by the Merrill Lynch Marks (including, without limitation, the right to renew any registrations included in the Merrill Lynch Marks, the right to apply for trademark registrations within the United States based in whole or in part upon the Merrill Lynch Marks, and any priority right that may arise from the Merrill Lynch Marks), the same to be held and enjoyed by Bank of America as fully and entirely as said interest could have been held and enjoyed by Merrill Lynch had this sale, assignment, transfer and conveyance not been made.
2. **Recordation, Necessary Documents.** Merrill Lynch authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the registrations and/or applications

for registration for the Merrill Lynch Marks to Bank of America as assignee of Merrill Lynch's entire right, title and interest therein. Bank of America agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Bank of America's ownership of the Merrill Lynch Marks.

3. **Multiple Copies.** This Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.
