## Trade Mark AGREEMENT

  2. The Omaha Nebraska Chapter of the American Veterans MC will stay under Paul Harlow's control or his designated member for all times, with all current members, future members and National dues paid forever with no sanctions placed on them.
  3. The ownership and use of the americanveteransmc.com web site along with the future use of the American Veterans MC, in name and graphic, is granted to Paul Harlow or his designated member to use for all times.
  4. The Omaha Nebraska Chapter will assume no liabilities other than for their own actions in the future.
  5. It is stipulated that any trade mark owner / owners added in the future must be in a Nebraska Chapter and reside in no other state.
  6. The new ownership agrees to release any and all claims they may have against Paul Harlow, the trade mark owner.

If any of these stipulations are not followed by the new owner / owners of this Trade Mark, American Veterans MC, this agreement shall become null & void and said Trade Mark will be returned to Paul Harlow or his heirs.
