TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of January 28, 2010 by (a) (i) QUESTIA MEDIA, INC., a Delaware corporation, (ii) QUESTIA MEDIA AMERICA, INC., a Delaware corporation, (iii) QUESTIA MEDIA INTERNATIONAL, LTD., a company organized under the laws of the British Virgin Islands, (iv) QUESTIA MEDIA OPERATIONS, L.P., a Delaware limited partnership, (v) QUESTIA MEDIA I, L.L.C., a Nevada limited liability company, (vi) QUESTIA MEDIA II, L.L.C., a Nevada limited liability company, (vii) QUESTIA MEDIA III, L.L.C., a Nevada limited liability company, and (viii) QUESTIA MEDIA IV, L.L.C., a Nevada limited liability company, ((i) through (viii) collectively, "Transferors"); to (b) THE GALE GROUP, INC., a Delaware corporation ("Buyer"). Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Purchase Agreement (as defined below).

RECITALS

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of January 22, 2010 (the "Purchase Agreement"), among other things, Transferors identified as "Sellers" therein have agreed to sell, convey, assign, transfer, and deliver (and to cause the other Transferors to sell, convey, assign, transfer, and deliver) to Buyer, and Buyer has agreed to purchase and assume, the Assets; and

WHEREAS, the Transferors are the owners of various registered and unregistered trademarks, service marks, trade names, trade dress, logos, business and product names that are among the Assets, including the trademark applications and registrations set forth on Schedule A attached hereto and all common law rights related thereto (the "Marks"); and

WHEREAS, it is a condition precedent of the closing of the transactions contemplated by the Purchase Agreement that Transferors execute and deliver this Assignment.

AGREEMENT

NOW, THEREFORE, in consideration of the agreements and covenants contained in the Purchase Agreement, and the premises set forth above, and for other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, the Transferors, intending to be legally bound, do hereby agree as follows:

1. Assignment. Transferors hereby sell, convey, assign, transfer, and deliver to the Buyer, and its successors and assigns:

(a) all of the Transferors' right, title, and interest in and to the Marks, and all common law rights related thereto, together with the goodwill of the business connected with the use of, and symbolized by, such Marks, including, but not limited to, all of the Transferors' right, title, and interest with regard to the ownership, renewal, protection, use, and exploitation of the same,

(b) all income, damages, or payments now or hereafter due or payable with respect to the Marks; and

(c) all claims, causes of action, actions, suits, or other proceedings, in law or in equity, for, past, present, or future infringement of the Marks, whether or not said Marks have been registered in the Patent and Trademark Office of the United States of America.

2. Power of Attorney. Transferors hereby irrevocably constitute and appoint Buyer and its successors and assigns the true and lawful attorneys of Transferors, with full power of substitution, in the name of Transferors or Buyer, but on behalf of and for the benefit of Buyer and its successors and assigns, solely to institute, prosecute, compromise, defend and settle any and all proceedings at law, in equity, or otherwise that it and its successors or assigns may deem proper in order to collect, assert, or enforce any claim, right, or title of any kind in or to the Marks, including the right to sue for infringement of the Marks, including past infringements, and to do all such acts and things in relation thereto as it and its successors and assigns shall deem desirable. Transferors shall fully cooperate with and assist Buyer in such proceedings as Buyer shall reasonably request. Transferors hereby declare that the appointment hereby made and the powers hereby granted are coupled with an interest and are and shall be irrevocable and perpetual and shall not be terminated by any act of Transferors or by operation of law, or by the occurrence of any other event, including, without limitation, the bankruptcy of Transferors, or in any other manner or for any other reason. The intent of this Assignment is to substitute the Buyer in the place of Transferors.

3. Binding Effect. This instrument is executed by, and shall be binding upon, Transferors, their successors and assigns, for the uses and purposes above set forth and referred to and shall inure to the benefit of Buyer, its successors and assigns.

4. Further Assurances. Transferors agree to execute all papers and to perform such other proper acts as Buyer may deem necessary to record the assignment made by this Assignment. In addition, Transferors, at Buyer's request, shall execute, acknowledge and deliver to Buyer such other instruments of conveyance and transfer and will take such other actions and execute and deliver such other documents, certifications and further assurances as Buyer may reasonably require in order to vest title more effectively in Buyer, or to put Buyer more fully in possession of, the Marks.

5. Terms of the Purchase Agreement. This Assignment is subject to all terms and conditions of the Purchase Agreement and in the event of a conflict or inconsistency between this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall prevail.


6. Governing Law. This Assignment will be governed by and construed under the laws of the State of New York without regard to conflicts of laws principles.
