Pursuant to Sections 3-102, 3-107, 3-109, 4A-701 and 4A-703 of the Maryland Corporations and Associations Article of the Annotated Code of Maryland, the undersigned submit the following for filing:

- 1. Towne Park, Ltd. and Avascend, LLC each agree to merge.
- 2. The name and place of incorporation or organization of the corporation and limited liability company party to the Articles of Merger are as follows:

- 3. The name and place of incorporation of the successor corporation is as follows:

- 4. The county in Maryland where the corporation and limited liability company party to the Articles of Merger, has its principal office are as follows:

- 5. Avascend, LLC, the limited liability company party to the merger, does not own an interest in land in any county in the State of Maryland.

- 6. The terms and conditions of the merger were advised, authorized, and approved by the corporation and limited liability company party to the Articles of Merger, in the manner and by the vote required by its charter and the laws of the State of Maryland. The manner of approval was as follows:

The merger was adopted and approved by the sole member of Avascend, LLC and by the Board of Directors of Towne Park, Ltd. pursuant to the terms and conditions of the Plan of Merger and in accordance with Section 3-105 of the Maryland General Corporation Law and Section 4A-702 of the Maryland Limited Liability Company Act.

7. No amendment to the corporate charter of Towne Park, Ltd., the successor, is to be effected as part of the merger.

8. As to Towne Park, Ltd.:

The total number of shares of stock of all classes which the corporation has authority to issue is 10,000,000 shares of common stock. There is only one class of stock in Towne Park, Ltd. The par value of the shares of common stock is \$0.01 par value, and the aggregate par value of all of the shares of all classes of stock is \$100,000.

9. As to Avascend, LLC:

Towne Park, Ltd. owns 100% of the membership interest in and to Avascend, LLC. There is only one class of membership interests in Avascend, LLC.

10. The manner and basis of converting or exchanging outstanding membership interests of the merging limited liability company into different stock of a corporation or other consideration, and the treatment of any outstanding membership interests of the merging limited liability company not to be converted or exchanged, are as follows:


Towne Park, Ltd., the successor, owns 100% of the outstanding membership interests of Avascend, LLC. On the Effective Date of the merger (as defined below), the interest of Towne Park, Ltd. in Avascend, LLC shall, by virtue of the merger and without any action on the part of Towne Park, Ltd., be cancelled simultaneously with the effectiveness of the merger. Each share of Towne Park, Ltd. stock that is issued and outstanding on the Effective Date shall continue as an outstanding share of Towne Park, Ltd.'s stock and shall retain identical designations, preferences, limitations and relative rights immediately after the Effective Date as it had prior to the Effective Date.

11. The merger shall become effective at 11:59 pm on December 31, 2009 (the "Effective Date").






