TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 2, 2010, is made by Union Bank, N.A., formerly known as Union Bank, a California banking corporation (the "Bank").

WHEREAS, the Bank and Cobra Golf Incorporated II, a California corporation ("Cobra"), entered into a certain Loan Agreement, dated July 24, 1991 (the "Loan");

WHEREAS, as collateral security for the Loan and pursuant to a certain Security Agreement - Trademarks dated as of July 24, 1991 (the "Security Agreement"), Cobra granted a first priority security interest to the Bank in all of Cobra's right, title and interest in and to certain collateral (the "Collateral" as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on August 9, 1991, at Reel 0806, Frames 0677-0709; and

WHEREAS, Cobra has fulfilled its obligations under the Loan and has requested that the Bank reassign to Cobra Golf Incorporated, a Delaware corporation and successor-in-interest to Cobra, all of the Bank's right, title and interest, if any, in and to the Collateral and release its security interest in the Collateral.

NOW, THEREFORE, for valuable consideration, the Bank hereby terminates and releases its lien on and security interest in the Collateral including the trademarks identified in Schedule A.
