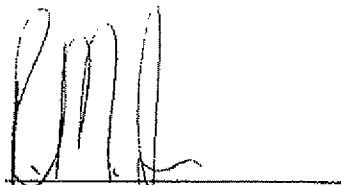
It is hereby certified that:
