IT IS HEREBY CERTIFIED:

FIRST: The name of the corporation is Mohawk Paper Mills, Inc. (the "Corporation").


SECOND: The Certificate of Incorporation of the Corporation was filed with the Department of State on August 23, 1972.


THIRD: The Certificate of Incorporation of the Corporation is hereby amended by deleting Article FIRST in its entirety and replacing it with the following:
