ASSIGNMENT OF TRADEMARKS

ASSIGNMENT AGREEMENT, dated April 30, 2005 (this "Agreement"), between International Paper Company, a New York corporation (the "Seller") and Mobawk Paper Mills, Inc, a New York, corporation (the "Buyer").

WITNESSETH:

WHEREAS, the Seller and the Buyer have entered into a Purchase Agreement dated as of March 30, 2005 (the "Purchase Agreement"), pursuant to which the Seller has agreed to sell to the Buyer all of Seller's right, title and interest in and to the trademarks registrations and applications listed in Schedule A attached to this Agreement and the trademarks to which said registrations and application pertain (collectively, the "Trademarks");

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Subject to the terms and conditions of this Agreement, the Seller hereby assigns to the Buyer all of Seller's right, title and interest in and to the Trademarks together with the goodwill of the business associated with the Trademarks and the right to sue for past infringement of the Trademarks. The Buyer hereby accepts such assignment.

2. This Agreement is being delivered pursuant to the Purchase Agreement and shall be construed consistently therewith.

3. EXCEPT AS PROVIDED IN THE PURCHASE AGREEMENT, THIS ASSIGNMENT IS "AS IS" AND THERE ARE NO WARRANTIES, EXPRESS OR IMPLIED, IN LAW OR IN FACT, WITH RESPECT TO THE TRADEMARKS.

4. Any capitalized term used herein and not otherwise defined shall have the meaning assigned to it in the Purchase Agreement.

5. If the Buyer deems any further instruments or assurances are necessary to carry out the terms of this Agreement, the Seller, at the Buyer's sole expense, shall execute and deliver all such instruments and assurances prepared by the Buyer reasonably necessary and proper to effectuate the provisions of this Agreement.

6. This Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

7. This Agreement shall be interpreted and enforced in accordance with the internal laws of the State of New York, without regard to conflict of laws principles that would result in the application of the laws of another jurisdiction.


ASSIGNMENT OF TRADEMARKS
