Pursuant to the Oregon Business Act (the "Act"), the undersigned, being respectively the President and Secretary of BIOTRONIK, INC., an Oregon corporation, hereinafter the "Surviving Corporation", and the President and Secretary of BIOTRONIK, INC., a Florida corporation, hereby adopt in duplicate the following Articles of Merger for the purpose of merging BIOTRONIK, INC., a Florida corporation into BIOTRONIK, INC., an Oregon corporation.

(1) The names of the undersigned corporations are BIOTRONIK, INC., a Florida corporation and BIOTRONIK, INC., an Oregon corporation, one corporation being organized under the laws of the State of Florida and the other being organized under the laws of the State of Oregon.

(2) The name of the Surviving Corporation is BIOTRONIK, INC. and it is to be governed by the laws of the State of Oregon.

(3) The Agreement and Plan of Merger ("Plan") between BIOTRONIK, INC., a Florida corporation and BIOTRONIK, INC., an Oregon corporation was approved by the shareholders of each of the respective corporations in the manner prescribed by the Act. The Plan is attached hereto as Exhibit "A" and by this reference is incorporated herein and made a part hereof.

(4) As to each of the undesigned corporations, the classes of shares outstanding, the number of shares of each class outstanding, the designation of the number of shares of each class entitled to vote as a class, the shares of each class voting for and against the Plan are as follows:

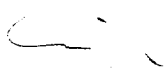

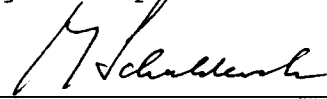
