**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

Reference is made to that certain Trademark Security Agreement (the "Security Agreement"), dated as of February 10, 2006 and recorded at the United States Patent and Trademark Office at Reel 3246 and Frame 0218 on February 13, 2006, by and between Equinox Holdings, Inc. a Delaware corporation, (the "Grantor"), and Hypo Real Estate Capital Corporation, a Delaware corporation, as administrative agent ("HRECC").

Pursuant to the Security Agreement, the Grantor granted to HRECC a security interest in the Grantors' right, title, and interest into the trademarks, trademark registrations and applications listed on Schedule A hereto (the "Trademarks").

HRECC (the "Releasor") hereby re-assigns and releases to the Grantor and terminates all right, title and interest that Releasor has in and to the Trademarks and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including, without limitation, all goodwill associated in any way with such Trademarks; the right to sue for past, present and future infringements, and all rights corresponding thereto associated with such Trademarks.

If and to the extent the Releasor or any of its predecessors, successors and assigns has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest, together with the goodwill of the business symbolized by such Trademarks, to the Grantor. The Releasor acknowledges and agrees that the Security Agreement has been terminated.

The Releasor shall take all further actions, and provide to the Grantor and its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this release, and hereby authorizes and requests the Director of Patents and Trademarks of the United States of America to record this release against the Trademarks.



To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademarks, the Releasor will execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

This release shall be binding upon the Releasor's representatives, successors, assigns and transferees.

This release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
