RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "**Release**"), dated as of December 7, 2009, is made by THE ROYAL BANK OF SCOTLAND PLC, as the collateral agent (the "**Collateral Agent**") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, GONDRA INC. (the "**Borrower**") (the parent company of DRAKE BEAM MORIN, INC.) and the Collateral Agent entered into that certain Credit Agreement, dated as of February 18, 2004 (as heretofore amended, the "**Credit Agreement**"), among the Borrower, the Collateral Agent, the other entities party thereto as guarantors and the various financial institutions party thereto as agents and lenders thereunder (each individually a "**Lender**", and collectively the "**Lenders**"), pursuant to which Credit Agreement the Lenders made credit extensions to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to that certain TRADEMARK SECURITY AGREEMENT, dated as of February 18, 2004 (the "**Trademark Security Agreement**") between DRAKE BEAM MORIN, INC. ("**Grantor**") and the Collateral Agent granted security interests in certain intellectual property owned by the Grantor listed on Annex I attached hereto (collectively, the "**Trademark Collateral**");


WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on March 16, 2004 and on reel 002814 and frame 0088; and

NOW THEREFORE, the Collateral Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Credit Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Trademark Collateral to the Grantor.

The Collateral Agent agrees, at the Grantor's expense, to cooperate with the Grantor and its Subsidiaries and to provide the Grantor and its Subsidiaries with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent's security interest in the released collateral described herein.
