NUNC PRO TUNC ASSIGNMENT

WHEREAS, AMERICAN GLASSMITH, INC. (f/k/a HOFFER'S OH HOLDINGS, INC., an Ohio Corporation, ("Assignor"), on or about December 10, 1997, assigned and transferred to AMERICAN GLASSMITH ACQUISITION CORPORATION, n.k.a.
