ASSIGNMENT OF TRADEMARKS

WHEREAS, Teledex LLC, a Delaware limited liability company, Telecom Industries LLC, a Delaware limited liability company, and TT Systems LLC, a Delaware limited liability company (individually "Debtor" and collectively "Debtors") defaulted in connection with the operative credit agreement and related loan documents between Debtors and TMX Funding, Inc., a Delaware corporation having its principal place of business at 5025 Galley Road, Colorado Springs, Colorado 80915 (the "Secured Party" and "Purchaser"), which was secured by certain collateral including, among other things, the trademarks and trademark registrations of Debtors identified on Schedule A attached hereto (collectively the "Marks") and goodwill connected therewith.

WHEREAS, at duly-noticed public foreclosure sales held on December 18, 2009 and January 13, 2010 and conducted by the Secured Party under Section 9610(c)(1) of the New York and California Uniform Commercial Codes, Purchaser purchased and acquired certain assets of Debtors including the Marks and related goodwill.

WHEREAS, the parties wish to further memorialize and confirm the transfer of the Marks and related goodwill from Debtors to Purchaser.

NOW, THEREFORE, for good and valuable consideration, constituting a credit bid against a portion of the obligations owed by Debtors to Secured Party, Debtors do hereby assign, transfer, convey and sell unto Purchaser, its successors and assigns all right, title, and interest in and to the Marks together with the goodwill of the business symbolized by the Marks, and any and all causes of actions including all rights of recovery for past infringements of the Marks. This assignment is binding on the successors and assigns of Debtors and inures to the benefit of the successors and assigns of Purchaser.

IN WITNESS WHEREOF, said Debtors, by and through Secured Party, pursuant to its legal and contractual rights, has executed and delivered this instrument this 5th day of March, 2010.

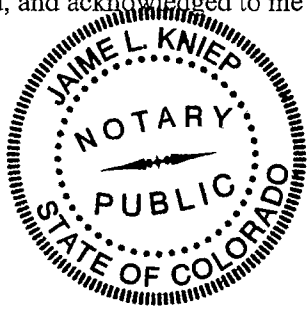
