**TERMINATION OF SECURITY INTEREST IN
TRADEMARKS**

This Termination of Security Interest in Trademarks (the "Termination"), dated as of March 9, 2010, is executed by WestBridge Ventures, L.P. ("Secured Party"), in favor of LANDesk Holdings, Inc., a Delaware corporation ("Grantor").

RECITALS

A. In connection with that certain Security Agreement, dated as of October 16, 2002 (as amended, revised or modified from time to time, the "Security Agreement"), between Grantor and the Secured Party, the Grantor and Secured Party entered into a Notice of Security Interest in Trademarks, dated as of October 16, 2002 (the "Agreement"), to secure the prompt and complete payment and performance of all of Grantor's Secured Obligations under the Security Agreement. All capitalized terms used herein and not otherwise defined have the respective meanings set forth in the Security Agreement.

B. The Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on October 18, 2002 at Reel/Frame 2600/0824 to evidence the security interest granted under the Agreement.

C. Grantor has paid in full and discharged all Secured Obligations due and secured by the Agreement and Secured Party has agreed to terminate and release its security interest in the Trademarks as more particularly described on Schedules 1-A and 1-B annexed hereto as part hereof (collectively, "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party expressly terminates and releases its security interest in, to and under all trademarks, trademark applications, service marks or service mark applications of the United States, more particularly described in Schedules 1-A and 1-B.

Secured Party authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental officer record this Termination.
