PARTIES

- (1) Dawson International Holdings (UK) Limited incorporated and registered in Scotland with company number SC054674 whose registered office is at Lochleven Mills Kinross KY13 8GL (the "Assignor").
- (2) Todd & Duncan Limited incorporated and registered in Scotland with company number SC355840 whose registered office is at 191 West George Street, Glasgow G2 2LD (the "Assignee").

Each a "Party" and together the "Parties".

BACKGROUND

- (A) The Assignor is the proprietor of the trade marks (registered, applications and unregistered trade marks) in the territories listed in the Schedule (the "Trade Marks").
- (B) The Assignor agrees to assign all its rights in and to the Trade Marks to the Assignee on the terms set out below.

AGREED TERMS

1. ASSIGNATION

In consideration of the sum of £1 paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns its entire right, title and interest in and to the Trade Marks including the benefit of the applications for registration with the intention that, when the applications are granted, any such registrations shall vest in the Assignee and any common law rights and all the goodwill attaching to the Trade Marks.

2. PROCEEDINGS

- 2.1 This Assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing off or any equivalent rights in any jurisdiction or for otherwise infringing the rights of the Assignor in the Trade Marks).
- 2.2 The Assignor agrees and undertakes to provide the Assignee (at its request) with all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Trade Marks.

3. FURTHER ASSURANCE

The Assignor covenants that, at the cost and request of the Assignee at any time and from time to time, it shall execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment and/or the recordal of any transfer to the Assignee under it.

4. MISCELLANEOUS

- 4.1 The Parties do not intend that this Assignment will be enforceable by any third party.
- 4.2 This Assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of Scotland.
- 4.3 The Parties irrevocably prorogate the non-exclusive jurisdiction of the Scottish courts to settle any dispute or claim that arises out of or in connection with this Assignment or its subject matter or formation (including non-contractual disputes or claims).
