NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR represents and confirms that prior to January 1, 2007, it had acquired goodwill associated with and symbolized by said Marks and had not abandoned the same;

WHEREAS, ASSIGNOR was, prior to January 1, 2007, the owner of the trademark registrations relating to the marks listed in Schedule A, attached hereto and incorporated herein by reference (hereinafter collectively referred to as the "Registrations");

WHEREAS, ASSIGNOR did assign to ASSIGNEE, as of the effective date of this Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Marks and Registrations worldwide, together with the goodwill and business associated therewith, and certain tangible assets as indicia of said goodwill;

WHEREAS, ASSIGNEE was desirous of acquiring all rights, title, and interest in and to the Marks and Registrations; together with the goodwill and business associated therewith, and certain tangible assets as indicia of said goodwill; and

WHEREAS, ASSIGNOR wishes to confirm its assignment of said Marks and Registrations to ASSIGNEE, as of the effective date of this Assignment.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby confirms its assignment and sale to ASSIGNEE of all rights, title, and interest as ASSIGNOR may possess in and to the Marks and Registrations set forth in Schedule A, together with the goodwill symbolized by said Marks and Registrations, concurrent with the transfer of certain tangible assets as indicia of said goodwill, *munc pro tunc* January 1, 2007.
