Trademark Assignment made as of the 12th day of May, 1998.



Without limitation of the generality of the interest conveyed, the conveyance includes (a) all of Champion's right, title, and interest (both statutory and common law) in and to the Trademarks; (b) any and all registrations and applications for registration thereof in the United States and throughout the world; and (c) all trademark enforcement rights and remedies which Champion may now have with respect to the Trademarks including Champion's standing to assert civil, criminal, and administrative remedies of all kinds and Champion's right to damages for past infringement thereof.
