The Assignor acknowledges and agrees that it shall execute and deliver at the request of the Assignee, all papers, instruments and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all of the Assignor's rights, title and interest in and to the Marks, including the Scheduled Marks, and the Domain Names, in the Assignee, including all documents necessary to record in the name of the Assignee the ownership of the Scheduled Marks and the Domain names with any applicable government office or registrar, as required to effectuate this assignment.




