## ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "*Purchase Agreement*"), dated as of August 7, 2009, between Assignor and Assignee, Assignor has agreed to assign all of its right, title and interest in, to and under the Marks to Assignee, and Assignee has agreed to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Purchase Agreement, Assignor hereby sells, assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in, to and under the Marks, whether statutory or at common law, including all right, title and interest in the applications and/or registrations identified on Schedule A, and the goodwill associated with such Marks in the operation of the business of radio broadcast stations.

This Assignment of Marks does not modify the Purchase Agreement.

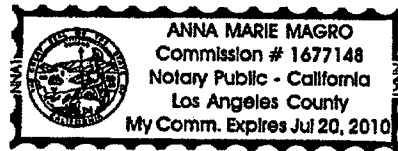
