**AMENDMENT AND RATIFICATION AND REAFFIRMATION OF NOTICE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

- TRADEMARKS -

WHEREAS, **TANDUS US, LLC**, a Delaware limited liability company and successor to Tandus US, Inc., a Delaware corporation, having its principal place of business at 311 Smith Industrial Boulevard, Dalton, Georgia 30721-8661, USA (the "**Grantor**"), is the owner of the trademarks and trademark applications set forth in Exhibit 1 (collectively, the "**Trademarks**"); and

WHEREAS, **BANK OF AMERICA, N.A.**, a national banking association having an office at 300 Galleria Parkway, Suite 800, Atlanta, Georgia 30339, USA, as administrative agent (together with its successors in such capacity, the "**Administrative Agent**"), entered into a Trademark Security Agreement dated as of January 18, 2007 with Grantor (as at any time amended, restated, modified or supplemented, the "**Security Agreement**") pursuant to which Grantor granted to the Administrative Agent a security interest in certain property, including the Trademarks, in consideration for a commercial loan; and

WHEREAS, Grantor and Administrative Agent entered into a certain Notice of Security Interest in Intellectual Property dated January 18, 2007 and recorded in the United States Patent and Trademark Office on April 12, 2007, at Reel 3521, Frame 589 (the "**First Notice**"), and a certain Notice of Security Interest in Intellectual Property dated May 8, 2007 and recorded in the United States Patent and Trademark Office on June 14, 2007, at Reel 3561, Frame 316 (the "**Second Notice**"; the First Notice and the Second Notice are hereinafter referred to collectively as "**Security Interest Notices**" and each individually as a "**Security Interest Notice**"); and


WHEREAS, Grantor has changed its name from "Tandus US, Inc." to "Tandus US, LLC" and, as a result thereof, Grantor and Administrative Agent desire to enter into this Amendment and Ratification and Reaffirmation of Notice of Security Interest in Intellectual Property in order to ratify and reaffirm Administrative Agent's security interest in the Trademarks;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby (i) confirms the granting to the Administrative Agent of a security interest in the Trademarks, (ii) ratifies and reaffirms the Security Agreement and the Security Interest Notices and all of Grantor's covenants, duties and liabilities thereunder, (iii) agrees that all references to "Tandus US, Inc." in each Security Interest Notice shall mean and be deemed to be references to "Tandus US, LLC", and (iv) authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Notice.
