CERTIFICATE OF MERGER

(Under Section 904 of the Business Corporation Law)

It is hereby certified, upon behalf of each of the constituent corporations herein named, as follows:

FIRST: The Board of Directors of each of the constituent corporations has duly adopted a plan of merger setting forth the terms and conditions of the merger of said corporations.

SECOND: The name of the domestic constituent corporation, which is to be the surviving corporation, and which is hereinafter sometimes referred to as the "surviving constituent corporation", is SR Outerwear, Inc. The date upon which its certificate of incorporation was filed by the Department of State is August 24, 2006.

THIRD: The name of the foreign constituent corporation, which is being merged into the surviving constituent corporation, and which is hereinafter sometimes referred to as the "merged constituent corporation", is S. Rothschild & Co., Inc. The jurisdiction of its incorporation is Pennsylvania; and the date of its incorporation therein is November 20, 1958.

The Application for Authority in the State of New York of the merged constituent corporation to transact business as a foreign corporation therein was filed by the Department of State of the State of New York on January 31, 1983.

FOURTH: As to each constituent corporation, the plan of merger sets forth the designation and number of outstanding shares of each class and series, the specification of the classes and series entitled to vote on the plan of merger, and the specification of each class and series entitled to vote as a class on the plan of merger, as follows:

SIXTH: The merger herein certified was authorized in respect of the merged constituent corporation in accordance with the laws of its jurisdiction of incorporation and is in compliance with said laws.

SEVENTH: The following is a statement of any amendments or changes in the certificate of incorporation of the surviving constituent corporation to be effected by the merger:

The Certificate of Incorporation of SR Outerwear, Inc. shall be amended to change the name of said corporation. To accomplish said amendment, Article First of the Certificate of Incorporation of SR Outerwear, Inc., shall be stricken out in its entirety, and the following new Article First shall be substituted in lieu thereof:

"FIRST: The name of the corporation is S. Rothschild & Co., Inc."
