NUNC PRO TUNC TRADEMARK ASSIGNMENT

THIS *NUNC PRO TUNC* TRADEMARK ASSIGNMENT is made and entered into effective as of December 10, 2003 (the "Effective Date") by and between JB Apparel, LLC, a New York limited liability company with an address at 1385 Broadway, 5th Fl., New York NY 10018, ("Assignor"), on the one hand; and US Design Group, Ltd., a New Jersey corporation with an address at 1385 Broadway, 19th Fl., New York, NY 10018 ("US Design"), on the other hand.

WHEREAS, Assignor is the owner of all right, title and interest in the trademark, service mark, and trade name, REQUEST, including a distinctive R Design shown as:



(collectively and individually, the "Mark"), the goodwill associated therewith, and U.S. Trademark Registration Nos. 1,587,912 and 2,973,790 for the Mark (the "Registrations"); and


WHEREAS, on or about the Effective Date, Assignor assigned all of its right, title, and interest in and to the Mark, the goodwill associated therewith, and the Registrations to US Design, and this *Nunc Pro Tunc* Trademark Assignment is intended to memorialize that prior assignment.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

Assignor hereby sells, assigns and transfers forever, free and clear of all liens and encumbrances, to US Design and its successors and assigns, all right, title, and interest in and to the Mark, together with the goodwill of the Mark and the goodwill of the business appertaining thereto and/or symbolized thereby, and the Registration, and all income, royalties, damages and payments now or hereafter due or payable in respect to the same, and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement and/or dilution of the same.
