### LICENSE AGREEMENT

This memorializes the License Agreement ("Agreement") made and entered into on April 1, 2006 ("Effective Date"), by and between SCRIPTO-TOKAI CORPORATION having its principal place of business at 2055 South Haven Avenue, Ontario, California 91761 ("Licensor"), and CALICO BRANDS, INC., a California corporation having its principal place of business at 2055 South Haven Avenue, Ontario, California 91761 ("Licensee").

The parties, on the Effective Date, mutually agreed and entered into the Agreement based upon the following terms:

1. Licensor is the owner of the following trademarks (the "Marks") and represents and warrants that, as of the Effective Date, it has the right to grant exclusive license hereunder and that there are no outstanding agreements, assignments, or encumbrances inconsistent with the provisions of the Agreement:

- (a) TURBO, U.S. Trademark Registration No. 1,520,063 for lighters
- (b) SCRIPTO, U.S. Trademark Registration Nos. 2,604,815 for utility lighters; Registration No. 1,225,976 for cigarette lighters, and writing instruments, namely, pens and pencils; and Registration No. 823,263 for cigar and cigarette lighters, and flints and wicks for lighters.

2. Licensor grants to Licensee an exclusive, royalty-free, perpetual, irrevocable license in the Marks for use in connection with lighters.

3. The Agreement becomes effective on the Effective Date and remains in effect, except that either party shall have the right to terminate the Agreement, by notifying the other party either orally or in writing, at least thirty (30) days prior to the expiration of its term.

4. Licensee shall have the right to enforce all rights in and to the Marks as well as the goodwill represented by the Marks and to seek and obtain any remedies for infringement of the Marks.

5. The Agreement shall be binding upon and inure to the benefit of each of the parties' successors, assigns, heirs, and transferees.

6. The Agreement shall be interpreted according to the laws of the State of California without regard to any law with respect to conflict of laws. Venue for any dispute arising under this Agreement shall be in California and each party shall make its officers, employees, and agents available in California for any such proceedings.

IN WITNESS WHEREOF, the parties hereto have memorialized the Agreement executed by their duly authorized representatives.


