RELEASE OF TRADEMARK COLLATERAL

(MOUNTAINEER PARK, INC.)

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of March 18, 2010, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the "Agent Bank"), the secured party under the Security Agreement referred to below.

WITNESSETH:

WHEREAS, MOUNTAINEER PARK, INC., a West Virginia corporation ("Mountaineer"), and certain other entities executed that certain Trademark Security Agreement, dated as of September 22, 2006 (the "Security Agreement"), pursuant to which Mountaineer granted a security interest to the Agent Bank in certain trademarks and other intellectual property of Mountaineer; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 2738, Frame 0183 on April 22, 2003; and

WHEREAS, the Agent Bank has agreed to release all its liens on the trademarks and trademark applications of Mountaineer identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Agent Bank hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Agent Bank's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
