INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT & BILL OF SALE

This Intellectual Property Assignment Agreement & Bill of Sale (the "IP Assignment Agreement"), dated as of March 14, 2010, is entered into by and between Delaware Capital Formation, Inc., a Delaware corporation ("DCF") and Triton ATMs, LLC, a Delaware limited liability company ("Buyer"). All capitalized terms used in this IP Assignment Agreement and not defined herein shall have the respective meanings ascribed to them in the Purchase Agreement executed by and among Buyer, Dover Engineered Systems, Inc., and Triton Systems of Delaware, LLC ("Triton") of equal date herewith (the "Purchase Agreement").

RECITALS

WHEREAS, Buyer is on the date hereof acquiring all of the issued and outstanding membership interests of Triton and the IP Assets pursuant to the Purchase Agreement;

WHEREAS, DCF and Triton are parties to that certain Intellectual Property License Agreement, dated January 1, 2003, pursuant to which DCF licenses Triton rights under certain patents, trademarks, copyrights, trade secrets and other intellectual property rights, including, without limitation, the IP Assets; and

WHEREAS, it is a condition to closing under the Purchase Agreement that DCF assign to Buyer the IP Assets, and DCF is willing to so assign the IP Assets on the terms provided for herein.

NOW, THEREFORE, the parties hereby agree as follows:

1. Assignment. In consideration of a portion of the Purchase Price paid by Buyer to Dover Corporation, as DCF's designee, DCF hereby assigns and transfers to Buyer, and Buyer hereby accepts, all of DCF's rights, title and interest in and to the IP Assets including all trademarks and service marks as set forth in Section 1.1(a) of the Disclosure Schedule, a copy of which is set forth on Exhibit A attached hereto, together with the goodwill of the business symbolized by said marks.

2. Further Assurances. DCF shall execute such other or additional instruments of transfer or conveyance in respect of the IP Assets as are reasonably requested by Buyer, including any applicable forms of assignment necessary for filing before the U.S. Patent and Trademark Office, or equivalent filings in foreign jurisdictions which may be reasonably necessary for vesting title to the IP Assets in Buyer, its successors, assigns and legal representatives or nominees. Notwithstanding the foregoing, Buyer shall use its commercially reasonable efforts to identify, prepare and file, within three (3) months following the date hereof, all such documents necessary to vest title to the IP Assets in Buyer.

3. Disclaimer. EXCEPT AS OTHERWISE SET FORTH IN THE PURCHASE AGREEMENT, THE TRANSFER OF IP ASSETS HEREBY IS MADE WITHOUT RECOURSE AND WITHOUT REPRESENTATION OR WARRANTY OF ANY KIND. The foregoing is not intended to limit any rights as between Buyer and Triton under the Purchase

Agreement. The parties hereto hereby acknowledged and agree that the transfer of the IP Assets hereby is subject to the terms of the Purchase Agreement and the assumptions and retentions of liabilities by the parties set forth therein.

4. Miscellaneous. This IP Assignment Agreement shall be governed by the internal laws of the State of New York. This IP Assignment Agreement may only be amended in writing signed by the parties. This IP Assignment Agreement, together with the Purchase Agreement, is the entire agreement between the parties with respect to the subject matter hereof. This IP Assignment Agreement may not be assigned to any party without the prior written consent of the other party. Any term of this IP Assignment Agreement that is found to be invalid or unenforceable shall not affect the validity and enforceability of the remaining terms of this IP Assignment Agreement. This IP Assignment Agreement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.
