DOW JONES TRADEMARK AND DOMAIN NAME ASSIGNMENT

THIS DOW JONES TRADEMARK AND DOMAIN NAME ASSIGNMENT (this "Assignment") is made and entered into as of March 18, 2010 ("Effective Date") by and between CME Group Index Holdings LLC (f/k/a CIMD Holdings, LLC), a Delaware limited liability company, located at 20 South Wacker Drive, Chicago, IL 60606 ("Assignor"), and CME Group Index Services LLC (f/k/a CIMD, LLC), a Delaware limited liability company, located at 20 South Wacker Drive, Chicago, IL 60606 ("Assignee"). All capitalized terms used, but not defined herein, shall have the meanings ascribed to such terms in the Contribution Agreement (defined herein below).

WHEREAS, News Corporation, a Delaware Corporation, Dow Jones & Company, Inc. ("Dow Jones"), a Delaware corporation, Dow Jones Trademark Holdings LLC (f/k/a Dingo Smith Trademark Holdings LLC), CME Group Inc., a Delaware corporation, Board of Trade of the City of Chicago, Inc., a Delaware corporation, Assignor and Assignee, have entered into that certain Contribution Agreement, dated February 10, 2010 (the "Contribution Agreement");

WHEREAS, pursuant to the Contribution Agreement, Dow Jones and Assignor have entered into a Trademark and Domain Name Assignment Agreement (the "Dow Jones Assignment"), dated March 18, 2010 whereby Dow Jones agreed to sell, convey, assign, and transfer to Assignor all of Dow Jones' right, title and interest in Trademarks of Dow Jones and its Affiliates that are primarily used in or held for use in the DJI Business, other than the Assigned Dow Jones Excluded Trademarks, including, but not limited to,

- (a) the Trademark registrations and applications set forth on Schedule A attached hereto, together with the goodwill of the business connected with the use of and symbolized thereby, (the "Assigned Marks");
- (b) the names of any Index, and the names of any family of Indexes, of Assignor, used in or held for use in the DJI Business (the "Index Names"), but excluding any Index Names that contain a Dow Jones Excluded Trademark and the Dow Jones Wine Indexes and Dow Jones Economic Sentiment Indicator (the "Dow Jones Index Names"; the Index Names, excluding the Dow Jones Index Names, are hereinafter referred to as the "Assigned Index Names"); and
- (c) the domain names set forth on Schedule B attached hereto (the "Assigned Domain Names");

WHEREAS, Assignee is a successor to that part of Assignor's business to which the Assigned Marks, Assigned Index Names, and Assigned Domain Names pertain, and that business is ongoing and existing; and

WHEREAS, Assignor has agreed to sell, convey, assign, and transfer to Assignee all of Assignor's right title and interest in the Assigned Marks, Assigned Index Names, and Assigned Domain Names that Assignor acquired in the Dow Jones Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, assigns, transfers and sets over to Assignee all of Assignor's right, title and interest in and to the Assigned Marks, the Assigned Index Names, and the Assigned Domain Names, for the United States and for all other countries, including, without limitation, all common law rights therein, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or of any other country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all goodwill connected with the use of and symbolized thereby, and income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Assigned Marks, the Assigned Index Names, or the Assigned Domain Names, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any other applicable countries, to record Assignee as the assignee and owner of the Assigned Marks.

Assignor shall, and shall cause its Affiliates to, take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), reasonably requested by Assignee, at Assignee's cost and expense, to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world, including the execution and delivery of assignments in recordable form, to the extent provided by Assignee and necessary to assign such rights.

Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of the Assignor and the Assignee under the Contribution Agreement.

This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or portable document format (.pdf) shall be as effective as delivery of a manually executed counterpart of this Assignment.

THIS ASSIGNMENT SHALL IN ALL RESPECTS BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF DELAWARE, INCLUDING BUT NOT LIMITED TO ALL MATTERS OF CONSTRUCTION, VALIDITY AND PERFORMANCE, IN EACH CASE WITHOUT REFERENCE TO ANY CONFLICT OF

LAW RULES THAT MIGHT LEAD TO THE APPLICATION OF THE LAWS OF ANY
OTHER JURISDICTION.


