DOW JONES EXCLUDED TRADEMARKS ASSIGNMENT

THIS DOW JONES EXCLUDED TRADEMARKS ASSIGNMENT (this "Assignment") is made and entered into as of March 18, 2010 ("Effective Date") by and between Dow Jones & Company, Inc., a Delaware corporation, located at 1211 Avenue of the Americas, New York, NY 10036 ("Assignor"), and Dow Jones Trademark Holdings LLC (f/k/a Dingo Smith Trademark Holdings LLC), a Delaware limited liability company located at 1211 Avenue of the Americas, New York, NY 10036 ("Assignee"). All capitalized terms used, but not defined herein, shall have the meanings ascribed to such terms in the Contribution Agreement (defined herein below).

WHEREAS, News Corporation, a Delaware Corporation, Assignor, CME Group Inc., a Delaware corporation, Board of Trade of the City of Chicago, Inc., a Delaware corporation, CME Group Index Holdings LLC (f/k/a CIMD Holdings, LLC), a Delaware limited liability company, CME Group Index Services LLC (f/k/a CIMD, LLC), a Delaware limited liability company, and Assignee, have entered into that certain Contribution Agreement, dated February 10, 2010 (the "Contribution Agreement");

WHEREAS, pursuant to the Contribution Agreement, Assignor has agreed to sell, convey, assign and transfer to Assignee all of Assignor's right, title, and interest in the following Trademarks:

(i) all Trademarks, other than domain names, that are (a) "THE DOW", "THE DOW [followed by a number]", "DOW JONES", "DJ", and "THE GLOBAL DOW", (b) primarily used in or held for use in the DJI Business and that contain any one of the five terms in (a), (c) any stylized form, variation, translation, transliteration, adaptation, or derivation of either (a) or (b), as well as related logos, in each case, that is primarily used in or held for use in the DJI Business, or (d) those trademark registrations and applications set forth on Schedule A attached hereto, and those common law trademarks set forth on Schedule B attached hereto, in each case, together with the goodwill of the business connected with the use of and symbolized thereby (the "Assigned Excluded Dow Jones Marks"), in each case excluding, for avoidance of doubt, any Excluded Dow Jones Marks not required to be transferred to Assignee pursuant to Section 2.08 of the Contribution Agreement (e.g., DOW JONES MARKETWATCH, DOW JONES BARRONS, DOW JONES FACTIVA, DOW JONES NEWSWIRE, DOW JONES THE WALL STREET JOURNAL);

(ii) the names of any Index or Index family of Assignor used in or held for use in the DJI Business that contain an Assigned Excluded Dow Jones Mark, excluding the Dow Jones Wine Indexes and the Dow Jones Economic Sentiment Indicator (the "Dow Jones Index Names"); and

WHEREAS, pursuant to the Contribution Agreement, Assignor and Assignee have agreed to enter into this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, assigns, transfers

and sets over to Assignee all of Assignor's right, title and interest in and to the Assigned Excluded Dow Jones Marks and the Dow Jones Index Names, for the United States and for all other countries, including, without limitation, all common law rights therein, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or of any other country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with the goodwill of the business connected with the use of and symbolized thereby, all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Assigned Excluded Dow Jones Marks or the Dow Jones Index Names, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any other applicable countries, to record Assignee as the assignee and owner of the Assigned Excluded Dow Jones Marks.

Assignor shall, and shall cause its Affiliates to, take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), reasonably requested by Assignee at Assignee's cost and expense to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world including the execution and delivery of assignments in recordable form, to the extent provided by Assignee and necessary to assign such rights.

Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of the Assignor and the Assignee under the Contribution Agreement.

This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or portable document format (.pdf) shall be as effective as delivery of a manually executed counterpart of this Assignment.

THIS ASSIGNMENT SHALL IN ALL RESPECTS BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF DELAWARE, INCLUDING BUT NOT LIMITED TO ALL MATTERS OF CONSTRUCTION, VALIDITY AND PERFORMANCE, IN EACH CASE WITHOUT REFERENCE TO ANY CONFLICT OF LAW RULES THAT MIGHT LEAD TO THE APPLICATION OF THE LAWS OF ANY OTHER JURISDICTION.
