**TRADEMARK RELEASE**

TRADEMARK RELEASE, effective as of this 19<sup>th</sup> day of March, 2010, given by WELLS FARGO BANK, NATIONAL ASSOCIATION with offices at 625 Marquette Avenue, Minneapolis, Minnesota 55479, to LONE STAR GROWERS, L.P., a Delaware limited partnership, (the "Grantor"), with principal offices at 2575 Olive Hill Road, Fallbrook, California 92028, as follows:

**WITNESSETH**

WHEREAS, the Grantor has heretofore granted to the Collateral Agent, as collateral agent to the Term A Secured Parties ("Term A Collateral Agent") and collateral agent to the Term B Secured Parties ("Term B Collateral Agent" and, together with Term A Collateral Agent, the "Collateral Agent") (each, to the extent not otherwise defined herein, as defined in that certain Amended and Restated Loan and Security Agreement, dated as of August 15, 2007, between the Collateral Agent, the Grantor, and the other guarantors party thereto (the "Loan Agreement")), a security interest in all of Grantor's right, title and interest in and to Grantor's U.S. trademarks, trademark registrations and trademark applications, including but not limited to those U.S. trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (collectively the "Trademarks") to secure the Obligations (as defined in Loan Agreement);

WHEREAS, a Patent, Trademark and License Mortgage executed by the Grantor and effecting the grant of the Trademarks was recorded in the United States Patent and Trademark Office on June 23, 2005, at Reel 003109, Frame 0599 and Reel 003109, Frame 0627; and


WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve any and all liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, terminates and relinquishes unto the Grantor the continuing security interest in such Grantor's right, title and interest in, to and under the Trademarks, whether then owned or thereafter acquired or arising wherever located.
