## DEED OF TRANSFER

This DEED OF TRANSFER is made as of the 11th day of March, 2010, between MARC-ALEXANDER LANGE ("Transferor") and BEVERAGE INNOVATIONS (INTERNATIONAL) LTD. a Commonwealth of Bahamas corporation ("Transferee"). Capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Asset Purchase Agreement (as defined herein).

WHEREAS, Kerry Inc., a Delaware corporation, Kerry Group Services International Ltd. ("KGSI"), Transferee, Beverage Innovations, Inc., a Florida corporation, Marc-Alexander Lange, James L. Day and Dennies Bergmann entered into an Asset Purchase Agreement dated as of March 11, 2010, (the "Asset Purchase Agreement");

WHEREAS, Transferor is the owner of Trademarks used in the Business including the trademark "T-WAVE" and "TEAWAVE"; and

WHEREAS, pursuant to the Asset Purchase Agreement, Transferee has agreed to assign all of its rights, powers, liberties and immunities in and to the Patents, Trademarks and Know-how to KGSI.

Now, this DEED witnesseth:

1. TRANSFER.

Transferor hereby transfers, conveys and assigns to Transferee and its successors and assigns all the rights, titles, powers, liberties and immunities conferred as proprietor thereof in and to the Trademarks including but not limited to "T-WAVE" and "TEAWAVE" worldwide, including all common law rights held by Transferor, all registrations and/or applications thereof, associated goodwill of the Business associated with the Trademarks and the right to sue for damages and other remedies in respect of any infringement of the Trademarks attaching thereto to hold unto Transferee absolutely for the full terms of such Trademarks.

2. COOPERATION.

From time to time after the date hereof, Transferor will, at its expense, execute and deliver such instruments and documents to Transferee, as Transferee may reasonably request, in order to more effectively vest in Transferee good title to the Trademarks and to otherwise more effectively transfer the Trademarks to Transferee.

3. REPRESENTATIONS AND WARRANTIES.

Except as set forth in the Asset Purchase Agreement and subject to such limitations as are contained therein, Transferor makes no representation or warranty as to the Trademarks.

4. SUCCESSORS AND ASSIGNS.


This Deed of Transfer shall be binding upon Transferor and its successors and assigns and shall inure to the benefit of Transferee and its successors and assigns. This instrument shall be effective as to the transfer of the Trademarks immediately preceding the Closing Date.

5. GOVERNING LAW

This Deed of Transfer shall be governed by and construed in accordance with the laws (as opposed to the conflicts of law provisions or rules) of the State of Delaware.


