## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of March 17, 2010 ("Effective Date") by and between (i) **Citibank, N.A.**, a national association, located at 2 Penn's Way, New Castle, Delaware 19720, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below), and (ii) **Solutia, Inc.**, a Delaware corporation, located at 575 Maryville Centre Drive, St. Louis, Missouri 63141 (the "Borrower"), and **CPFilms Inc.**, a Delaware corporation, located at 4210 The Great Road, Fieldale, Virginia 24089 ("CPFilms," and together with the Borrower, the "Grantors").

**WHEREAS**, reference is made to (i) that certain Credit Agreement dated as of February 28, 2008 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among the Borrower, Solutia Europe SPRL/BVA (formerly known as Solutia Europe SA/NV), Flexsys SA/NV, Collateral Agent, Citibank, N.A. as administrative agent (in such capacity, the "Administrative Agent") for the Lenders (as defined herein), the lending institutions from time to time party thereto (the "Lenders"), Citibank International plc, as European Collateral Agent, and the other parties thereto, and (ii) that certain Security Agreement dated February 28, 2008 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Borrower, CPFilms, certain other subsidiaries of Borrower, and the Collateral Agent, which Security Agreement has been given by each Grantor (and the other grantors party thereto) in favor of the Collateral Agent for the benefit of the Secured Parties (capitalized term used but not otherwise defined herein shall have the meaning set forth in the Credit Agreement or the Security Agreement, as the case may be);

**WHEREAS**, pursuant to the Security Agreement, Grantors executed and delivered to Collateral Agent that certain Trademark Security Agreement dated February 28, 2008 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "ABL Trademark Security Agreement") in favor of the Collateral Agent for the benefit of the Secured Parties;

**WHEREAS**, pursuant to the terms and conditions of the ABL Trademark Security Agreement, each Grantor pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined in the ABL Trademark Security Agreement);

**WHEREAS**, the ABL Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 6, 2008 at Reel/Frame 3733/0385; and

**WHEREAS**, Grantors have requested that Collateral Agent release its lien on and security interest in the Trademark Collateral, including those trademarks included in the Trademark Collateral set forth on Schedule A hereto (the "Released Trademark Collateral") granted pursuant to the ABL Trademark Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties and itself, hereby terminates, cancels and releases its lien on and security interest in the Released Trademark Collateral granted pursuant to the ABL Trademark Security Agreement and hereby assigns and transfers to the Grantors any right, title and interest it may have in, to and under the Released Trademark Collateral granted pursuant to the ABL Trademark Security Agreement.


The release set forth herein shall be without recourse to or warranty by the Collateral Agent and shall relate solely to the Released Trademark Collateral.
