NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of March 25, 2010, is made with regard to CARETEK, INC., a Colorado corporation, whose address and principal place of business is 9911 East 47th Avenue, Denver, Colorado 80238 (the "Debtor"), by FIRST BUSINESS CAPITAL CORP., a Wisconsin corporation, whose address and principal place of business is 401 Charmany Drive, Madison, Wisconsin 53719 (the "Secured Party").

R E C I T A L S:


