**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

Patent and Trademark Security Agreement dated June 29, 2001 (the "Security Agreement"), by Borrower in favor of Secured Party.


WHEREAS, Secured Party acknowledges full payment, performance and satisfaction of all obligations secured by the Security Agreement; and
