RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 29, 2010, is made by Regions Bank, as successor in interest to Amsouth Bank, an Alabama banking corporation with its principal place of business located at 315 Deaderick Street, 3rd Floor, Nashville, TN 37237-0310 (the "Secured Party") in favor of American Sentinel University, LLC, as successor in interest to Accis Acquisition, LLC, an Alabama limited liability company ("Grantor")

WHEREAS, the security interest granted to the Secured Party pursuant to the Security Agreement was recorded at the United States Patent and Trademark Office on January 25, 2006 at Reel 3295 and Frame 0946;

WHEREAS, all obligations of Grantor secured by the Security Agreement have been satisfied fully; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Trademarks.


