TRADEMARK ASSIGNMENT AGREEMENT

THIS AGREEMENT is made this 25th day of March, 2010 by and between Jeremy M. Stamper, an individual ("Assignor"), and Amazon Technologies, Inc., a Nevada corporation ("Assignee").
