





**NINETH.-** ATENTO compels to use in the economic traffic the trademarks licensed by this agreement, and to inform TELEFÓNICA, about the products and services relating to which the trademarks have been used.

To that purpose, as long as TELEFÓNICA requests it and necessarily 6 months before the renewal of the trademark before the corresponding Trademark Office, ATENTO shall provide TELEFÓNICA supporting evidence of the use.

**TENTH.-** ATENTO ensures that the products bearing the trademarks and the services rendered under the same shall have the adequate quality to maintain the prestige of the licensed trademarks, and it shall be solely and directly liable for the defects of the products it shall manufacture, sale or distribute and that bear the licensed trademarks and of the services rendered under the same.

**ELEVENTH.-** If ATENTO makes use of the licensed trademarks that, at the discretion of TELEFÓNICA, threaten its image or the value of the mentioned trademarks, ATENTO shall make, at TELEFÓNICA's request, the relevant corrections in the latter's opinion.

**THIRTEENTH.-** ATENTO may exercise on its behalf the actions that are recognized to the holder of the trademark against third parties infringing its right, as long as it has obtained, prior to their exercise, the approval and instructions of TELEFÓNICA, which in every case reserves the management, control and supervision power.

**FOURTEENTH.-** ATENTO shall request the registration of the license before the corresponding Trademark Office, assuming the expenses deriving from the procedure, as well as the rest of the expenses and taxes derived from its signing.

**FIFTEENTH.-** TELEFÓNICA reserves the unilateral power of giving notice of its intention to terminate the agreement and of putting an end to the effect thereof at any

time during its validity in case its shareholding in ATENTO diminishes. At the termination of this agreement, all those sublicense agreements that according to the third statement may have been granted by ATENTO, shall be terminated.

Due to the exercise of such power, neither ATENTO nor any of the sub-licensors shall have the right to demand a consideration or compensation.

**SIXTEENTH.-** Without prejudice to what has been provided in the fifteenth statement, this agreement shall automatically terminate for the general causes admitted according to Law, especially, by mutual agreement and non-fulfilment of any of the part of their obligations, rendering null and void the rights deriving therefrom.

**SEVENTEENTH.-** The parties, with express waiver to their own jurisdiction or to the jurisdiction that may correspond to them, in as many lawsuit matters as arise, with an agreement interpretation, application or fulfilment purpose, submit themselves to the jurisdiction or competence of the Courts and Tribunals of Madrid-Capital.
