**NOW, THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby assign to ASSIGNEE all rights, title and interest in and to the Registered Trademarks, together with the goodwill of the business symbolized thereby, and ASSIGNOR agrees to execute all papers and to perform such other proper acts as ASSIGNEE may reasonably deem necessary to secure to said ASSIGNEE all rights herein assigned.


