TRADEMARKS AND TRADEMARK APPLICATIONS



WHEREAS, Assignees wish to terminate the Agreement and release, retransfer and reassign to Assignors, without representation or warranty, all of Assignees' right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignees hereby terminate the Agreement and release, retransfer and reassign to Assignors, without representation or warranty, all of Assignees' right, title and interest in and to the Marks and the goodwill associated therewith.
