AMENDED AND RESTATED LIMITED SECURITY AGREEMENT
(PATENTS AND TRADEMARKS)**

TERMINATION AND RELEASE OF AMENDED AND RESTATED LIMITED SECURITY AGREEMENT (PATENT AND TRADEMARKS) dated as of March 31st, 2010, by NALLEY(S CANADA LIMITED (the [Secured Party]), a British Columbia corporation.

WHEREAS, Snack Alliance, Inc., an Oregon corporation (the [Grantor]), and the Secured Party entered into an Amended and Restated Limited Security Agreement (Patents and Trademarks), dated June 18, 2009, and made effective as of July 2, 2009 pursuant to the terms of the Effective Date Agreement, by and between the Secured Party, the Grantor, and the other parties party thereto (the [Security Agreement]), which Security Agreement was recorded with the United States Patent and Trademark Office. Registered patents were recorded on August 20, 2009, at Reel 023124, Frame 0839, and issued trademarks were recorded on August 20, 2009, at Reel 4049, Frame 0609, for the purpose of collateral security for all Indebtedness and obligations of the Grantor to the Secured Party arising under those certain Loan Documents (as defined in the Security Agreement);

WHEREAS, pursuant to the Loan Documents and the Security Agreement, the Grantor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Collateral (as defined in the Security Agreement), including, without limitation, the patents listed on Exhibit A hereto, and the trademarks listed on Exhibit B hereto; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Collateral as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Collateral, including, without limitation, the patents listed on Exhibit A hereto and the trademarks listed on Exhibit B hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Collateral, effective as of the date set forth above.


