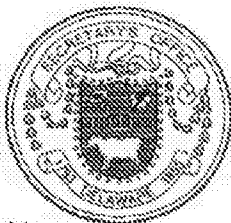

Pursuant to the provisions of Section 251 of the Delaware General Corporation Law (the "DGCL"), the following Certificate of Merger is executed as of July 16, 2008:

FIRST: The names of the constituent corporations to the merger are:

- (a) Restore Medical, Inc., a Delaware corporation; and
- (b) MRM Merger Corporation, a Delaware corporation.

SECOND: An Agreement and Plan of Merger, dated April 22, 2008, was approved, adopted, certified, executed and acknowledged by each of Restore Medical, Inc. and MRM Merger Corporation in accordance with the provisions of the DGCL.

THIRD: The name of the surviving corporation is Restore Medical, Inc. (the "Surviving Corporation"). The name of the Surviving Corporation shall be amended in the merger to be "Medtronic Restore Medical, Inc."

FOURTH: The merger shall be effective at the time this Certificate of Merger is filed with the Delaware Secretary of State.

FIFTH: The Amended and Restated Certificate of Incorporation attached hereto as Exhibit A shall be the Certificate of Incorporation of the Surviving Corporation as of the effective date of the merger.

SIXTH: The Board of Directors of MRM Merger Corporation shall be the Board of Directors of the Surviving Corporation as of the effective date of the merger.

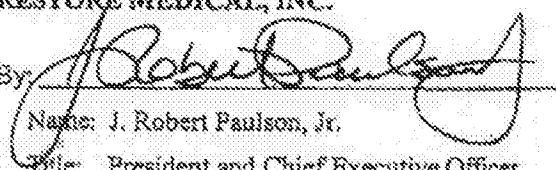
